Course Overview

This 5-day professional development course supports educators in integrating Artificial Intelligence (AI) and digital tools into inclusive, student-centred teaching practices. The programme aligns with European priorities on digital transformation, inclusion, and innovation in education. Participants will critically explore AI applications for differentiation, accessibility, formative assessment, and learner autonomy while examining ethical considerations such as algorithmic bias, data protection (GDPR), and academic integrity.



Course Overview

Through collaborative workshops, cross-cultural exchange, and design-based learning, participants will develop practical AI-enhanced lesson plans and institutional implementation strategies. The course fosters sustainable professional growth and supports participants in transferring innovative practices to their home institutions.

By the end of the course, participants will be able to:

- 1. Explain key AI concepts and analyse their implications for inclusive and student-centred education in European contexts.**
- 2. Evaluate AI and digital tools using pedagogical, ethical, and accessibility criteria.**
- 3. Design differentiated learning activities aligned with Universal Design for Learning (UDL) principles.**



4. Apply AI tools to enhance formative assessment, feedback, and learner autonomy.
5. Identify and address ethical challenges related to data privacy, bias, and academic integrity in line with European regulations.
6. Collaborate with international peers to exchange good practices in AI integration.
7. Develop a sustainable action plan for implementing responsible AI practices in their educational setting.

- Debate: AI and academic integrity
- Policy drafting workshop: Classroom AI guidelines
- Group reflection

Outcome of Day 4:

Participants develop ethical awareness and draft responsible-use guidelines.

Day 5: Design Lab – Building AI-Enhanced Learning Experiences

Focus: Integration and application

Activities:

- Recap and synthesis
- Project-based workshop: Design a complete AI-enhanced lesson plan
- Peer review and structured feedback
- Presentation of projects
- Personal action planning
- Course evaluation

Final Outcome: Participants leave with a ready-to-implement AI-integrated lesson and a strategic action plan.

- **Collaborative group work**
- **Case study analysis**
- **Reflective practice**
- **Peer feedback sessions**
- **Design-based learning**

CANCELLATION POLICY

Teachers Education Academy reserves the right to cancel a pre-approved course in the event of multiple cancellations, at least 4 weeks before the start of the course, where the minimum number of participants (7) can no longer be guaranteed. In this case, the entire course fee paid will be refunded to the participants. However, Teacher Training Academy is not responsible for any other expenses (transportation tickets, accommodation reservations, etc.) that may occur during the course organization of the participants. We recommend that you do not make travel and accommodation reservations without course confirmation.



CANCELLATION POLICY

- A non-refundable Registration Fee of € 100.00 per Participant is payable at the time of submission of registration form. However, this amount will be paid without interruption if the course is cancelled by the Teachers Education Academy. This registration fee is included in the program fee.
- Total payments can be paid in 2 instalments, but the entire program fee must be completed 30 days before the start of the program. If you register 1 month before the course start date, the entire agreed amount must be paid in advance.



- The participant does not pay any fee if a notice of termination is made to TEACHER EDUCATION ACADEMY 30 working days before the first day of the training. Payments made up to that time will be paid without interruption, minus the € 100 pre-registration fee.
- If the participant terminates the contract 5 to 29 working days before the first day of the training, he/she must pay 50% of the agreed costs.
- If the participant terminates the contract within 5 working days from the first day of the training, he/she has to pay 100% of the costs.
